UZBEKISTAN. *Asian Review* London. July, 1955. pp. 255-260. An abridged report of a conference of historians held in Tashkent in 1954 to discuss problems affecting the study of the history of the peoples of Central Asia.

CHEZ LES POTIERS NABEULIENS, P. and L. A. Lisse. IBLA, Tunis. 1954. pp. 375-399. An historical sketch and detailed description of the methods used in the work. Illus.

CONTRIBUTION À L'ÉTUDE DE L'ÉCOLIER ALGÉRIENNE. George Rioux. IBLA, Tunis. 1954. pp. 369-372. Deductions made from psychological tests.

ECONOMIC PROBLEMS IN THE GAZA STRIP. James Baster. *The Middle East Journal*, Washington. Summer, 1955. pp. 323-327. An appalling picture of conditions in an area, normally supporting 70,000 people with difficulty and now, with the help of UNRA and the Egyptian Government, trying to cope with 300,000, over 200,000 of whom are refugees — mainly from Israel.

L'ÉCONOMIE DE LA TUNISIE, I and II. Raymond Barra. IBLA, Tunis. 1954, parts 3 & 4. pp. 203-224, 353-368. Presents a plan for economic improvements to combat various evils, such as instability, an antiquated land tenure system, and low productivity — inadequate for a fast-growing population.

FAMILY LIVING IN MODERN TURKEY. Rachel L. Rustow. *Child Study*, New York. Spring, 1955. pp. 19-25. Describes middle-class families and their methods of rearing their children.

THE HARNESSING OF THE TIGRIS, Iraq. *Islamic Review*, Woking. August, 1955. pp. 14-18. An account of the proposed Wadi Tharthar Flood Relief Scheme with its centre at famous Saamurra.

IMMIGRANT ABSORPTION AND SOCIAL TENSION IN ISRAEL. Samuel J. Klausner. *The Middle East Journal*, Washington, D.C. Summer, 1955. pp. 281-294. A case study of Iraqi immigrants.

L'ODIERNO ORDINAMENTO DEGLI STUDI ISLAMICI NELLA 'MADRASA' MĪR-I-'ARAB DI BUKHAHA. Alessandro Bausani. *Oriente Moderno*, Roma. August-September, 1954. pp. 395-404. Gives programme of studies for 1953-1954 and surveys the development of education in Bukhara for the last fifty years.

- PORTRAIT OF A YEMENITE WEAVER'S VILLAGE. S. D. Goitein. *Jewish Social Studies*, New York. January, 1955. pp. 3-26. Reports life in a village transplanted in Israel in 1950.
- SOCIAL CLASSES AND TENSIONS IN BAHRAIN. Fahim I. Qubain. *The Middle East Journal*, Washington, D.C. Summer, 1955. pp. 269-280. Although 96% of the population is Muslim, there is considerable friction between the 'Shī'ah and Sunnī factions as well as among the Jews, Persians and Indians found on the island.
- WATERS OF THE EL-GHAAB VALLEY TRAPPED TO EXPAND LAND AND POWER. *The Arab World*, New York. September, 1955. p. 3. Describes plans for Syria's great reclamation project.

- THE CONCEPT OF ISLAMIC COMMUNITY AND MODERN THEORIES OF NATIONALITY. *The Islamic Review*, Woking. August, 1955, pp. 6-13. Includes the "Emergence of Pakistan" by A. K. Najmul Karīm and the "Malay Muslim community" by Dato Megat 'Osmān.
- FRANCE IN ALGERIA. *The Islamic Review*, Woking. September, 1955. pp. 25-33. Covers the results of fifty years of French rule on the religious life of the country.
- THE MEDITERRANEAN WORLD. *Current History*, New York. August, 1955. Whole Issue. Deals in particular with events and conditions in Turkey, Libya, the Arab League States and Mediterranean strategy.

- WESTERN TECHNOLOGY AND THE ARAB WORLD. A. L. Tibawi. *The Quarterly Review*, London. January, 1955. pp. 75-88. Western scientific training without Western domination is welcome throughout the Near East, but Russian Communism is introducing a new and vigorous influence.
- THE ANGLO-EGYPTIAN AGREEMENT. Albert Hourani. *The Middle East Journal*, Washington, D.C. Summer, 1955. pp. 239-255. Surveys the background and results of the agreement of 1954.
